

Controlled Substance Disposal Rx Destroyer

PURPOSE

The DEA requires that all registrants provide effective controls and procedures to guard against theft and diversion of controlled substances. UF EH&S has reviewed the product Rx Destroyer and has found this product to be compliant with the DEA's controlled substance destruction requirements for Schedules I-V. This document summarizes the proper management, destruction, and documentation of expired controlled drugs in accordance with the Title 21 CRF Parts 1330.

This information applies only to PIs with an active DEA registration. PIs with expired or terminated registrations should reach out to EH&S for guidance.

PROCEDURES

- 1. Identify the Controlled Substances (CS)
 - a. When a controlled substance expires, or is no longer needed, write **EXPIRED** directly on the bottle with a marker.
 - b. Segregate marked bottle from other in-date controlled substances.
 - c. Log the substance out appropriately on the substance's log sheet.
- 2. Carefully Read all Instructions on DEA Form 41 (usdoi.gov)
- 3. Render expired controlled drugs non-retrievable(destroyed)
 - a. Label Rx Destroyer container in accordance with Hazardous Waste Management requirements and include accumulation start date.
 - b. Place the expired controlled substance(s) into the Rx Destroyer container with a witness present.
 - c. Triple rinse empty container and dispose of rinsate in Rx Destroyer.
 - d. Once the container is full, or all controlled substances marked for disposal are processed, continue to step 4.
- 4. Complete DEA Form 41 (usdoj.gov)
 - a. DEA Form 41, is available online and must be completed for each date that expired controlled substance(s) is/are destroyed.
 - b. A witness must be present. Valid Witness includes:
 - i. Lab Member familiar with the research
 - ii. Department faculty or staff familiar with the research
 - iii. UPD
- 5. Contact EH&S to properly dispose of Rx Destroyer Container
 - a. Follow EH&S guidance for waste accumulation per Waste Accumulation » UF | EHS (ufl.edu)
 - b. Contact EHS for pick-up by completing the on-line <u>Hazardous Waste Forms</u> » <u>UF | EHS (ufl.edu)</u>.
 - c. EHS will pick up your RX Destroyer container and ship it for incineration.
